University Grants Commission (Credit Framework for Online Learning Courses through Study Webs of Active Learning for Young Aspiring Minds) Regulations, 2021 was published at New Delhi, on 25th March, 2021. The following directions recommended by UGC are presented for approval.

- 1.a. A student is allowed only up to forty per cent of the total courses, being offered for a particular programme in a semester, through the online credit course, through SWAYAM platform.
- 1.b. The academic council may allow the Dean (Academics) to approve the online credit courses offered through SWAYAM platform for credit transfer on the recommendations of the Head of the Department.

In addition, the modifications to the present rules regarding integration of online courses are given below:

- 2.a. A student can take 20% of 40% courses as said in through other genuine online learning platforms duly approved by Dean (Academic).
- 2.b. For all MOOC courses the credits/grades will be fixed by the Head of the Department who is also the BoS chairman and approved by Dean(Academics)

- 2.c. For all type of online courses, chosen by a student, a course coordinator will be assigned and she/he shall be in-charge of the assessment and grade related entries in to the software.
- 2.d. The syllabus of the courses other than OE chosen from online should have a similarity of not less than 80% with the same course designed in the curriculum.
- 2.e. The evaluation of all other courses excluding OE will be done by the University with respect to OBE assessment pattern, a student will be allowed to take examinations for genuine reasons at PMIST for OE MOOC courses.

Supplementary exams related to the MOOC courses will be conducted by PMIST.

The above recommendations supersede the regulations related to integration of MOOC courses into credit framework given in the  $22^{nd}$ ,  $23^{rd}$  and  $24^{th}$  Academic Council Agenda points no.VC 22.1.5 / Dated:24.10.2015, Dean Research 23.7.10 / Dated:23.04.2016 and VC 24.1.8 / Dated:24.09.2016.


