TO CONSIDER AND APPROVE THE AMENDMENTS IN THE REGULATIONS – 2023 REGARDING HONOURS DEGREE IN ALL PROGRAMMES WITH OR WITHOUT SPECIALIZATIONS.

RESOLVED TO APPROVE the amendment in the Regulations 2023 for the award of the Honours degree in all programmes offered at Periyar Maniammai Institute of Science & Technology with or without domain specific specializations.

RESOLVED TO RECOMMEND the option for the students to enroll for Honours Degree only at the end of the second semester of each programme provided the students have minimum of 8.0 CGPA at the end of first year having passed all the courses in the first attempt.

RESOLVED TO RECOMMEND adopting AICTE guidelines that students opt for award of Honours Degree should earn 18 to 20 additional credits by registering for 5 or 6 additional domain specific courses from Semester III to Semester VII in addition to mandatory credit requirement.

RESOLVED TO ALLOW the students opting for Honours Degree to learn one or two courses online as per the Regulations of the Institute.

RESOLVED TO APPROVE the guidelines (i.e., eligibility criteria, registration procedure, additional course work requirement and award of Honours qualification) to be followed by the Institute regarding award of Honours degree as stated below.

REGULATIONS RELATED TO AWARD OF HONOURS DEGREE

B.Tech.(Hons.) Degree Programme

Honours is a specialized degree that focuses on the area of the students' interest, which encourages advanced levels of study and multidisciplinary learning. Honours qualification enhances professional development and facilitates gaining recognition at the time of graduation for advanced and distinguished work contributed by the undergraduate students.

Eligibility Criteria for Registration

Every student at the Institute intending to register for the "Honours" qualification shall fulfill the following academic requirements:

- a. Registration to "Honours" qualification shall start from third semester onwards.
- b. Students should have passed all the courses of first and second semesters in the first attempt and have an overall 8.0 CGPA.
- c. The lateral entry students / B.Sc. graduates should undergo two additional courses as recommended by the respective department, one course in the 3rd semester and the other course in the 4th semester.

Registration Procedure

- Any student who meets the eligibility criteria specified above and intends to register for the "Honours" qualification shall apply to the Institute through HoD in a prescribed form along with the prescribed application fee within 15 days after notification by the Institute.
- ii. There will be no limit on the intake of students for registration for "Honours" qualification.
- iii. Notification for approved registrants will be notified by the Dean (Academic Courses) within a week after application.
- iv. If registered, the students shall pay a one-time non-refundable registration fee as prescribed by the Institute to confirm the registration.

Additional Course Work Requirement

- i. "Honours" Degree shall be awarded to well performing UG students on earning the specific extra credits after satisfying the relevant degree award conditions.
- ii. In addition to the courses prescribed by the Institute to be completed successfully in all the semesters for the relevant degree award, each student registered for "Honours" degree qualification shall have to take up additional course works that lead to an additional 18 to 20 credits as recommended by AICTE.
- iii. All the additional course works should be completed within the minimum prescribed time for the award of the degree.
- iv. Students should obtain the grade >= A in all the additional course works.

Award of "Honours" Qualification

- i. All the students who successfully complete the additional courses as prescribed and satisfied the requirement shall be eligible for the award of "Honours" degree.
- ii. "Honours" Degree shall be awarded to well performing UG students on earning the specific additional credits as prescribed and satisfying the requirement and the relevant degree award conditions.
- iii. Students should have obtained a CGPA >= 8.0 at the end of the eighth semester and have satisfied additional credits consideration prescribed for "Honours" degree.

Guidelines

i. The Dean (Academic Courses) of the Institute shall submit the list of students who are eligible for the award of the "Honours" degree along with the total credits earned by each student to the Office of the Controller of Examinations. The list shall be validated by the Faculty Advisors of the students under consideration and endorsed by the Head of the Department.

- ii. If the students registered for "Honours" qualification cannot meet the requirement as stated, they shall not be considered for the award of "Honours" degree. However, they shall be awarded only B.Tech. degree or B.Tech. degree with Specialization.
- iii. Students may continue or deregister from the "Honours" qualification if they do not meet the specified requirement.
- iv. The "Honours" qualification shall be suffixed to the respective degrees and shown in the degree certificate as a recognition of higher achievement by the student concerned.
- v. All the students fulfilling the requirement shall be entitled to receive the transcripts indicating both their achievements.

TO CONSIDER AND APPROVE THE AMENDMENTS IN THE REGULATIONS – 2023 REGARDING INCLUSION OF GRADE POINT AVERAGE IN THE GRADE CARD EVEN IF A STUDENT HAS FAILED IN ONE OR MORE COURSES IN A SEMESTER.

RESOLVED TO APPROVE to include the Grade Point Average (GPA) measure for each semester in the grade card / sheet even when a student fails in one or more courses within a semester.

TO CONSIDER AND APPROVE THE AMENDMENTS IN THE REGULATIONS – 2023 REGARDING WAIVING OF AC044.10 INTERNAL ASSESSMENT MARKS FOR STUDENTS WHO ARE UNABLE TO PASS THE COURSE AFTER A SPECIFIED NUMBER OF ATTEMPTS

RESOLVED TO APPROVE the amendments to be made in the regulations - 2023 regarding waiving of internal assessment marks for students who are unable to pass the course after **two** number of attempts.

RESOLVED TO RECOMMEND if a student fails to obtain pass marks (Internal Assessment + End Semester Examination) in the third or subsequent attempts, then the student shall be declared to have passed the examination if he / she secures a minimum of 50 percent marks prescribed for the University end semester examinations (40 percent marks in case of Arts and Science programmes) by waiving the Internal Assessment marks.

RESOLVED TO RECOMMEND the rule of waiving the internal assessment marks shall be implemented from the current academic year.

- 1. Only those Students who obtained "RA" grade and have prescribed attendance and above in a course are eligible to apply for Supplementary Examination.
- 2. Registration shall be made for supplementary examination within the stipulated period from the date of notification.
- 3. A student is eligible for only one Supplementary Examination for any course. No second chance will be given. In case a student fails in the Supplementary Examination, he / she must rewrite the examination along with the regular stream in the subsequent semesters, as and when it is conducted.
- 4. Students who miss the end-semester examination due to valid medical or some other reason may be permitted with the consent of the Dean (Academic Courses) to appear for the supplementary examination(s) subject to fulfilling of attendance requirement.
- 5. Supplementary Examinations will be conducted during the first two weeks after the commencement of the next semester.
- 6. Supplementary examination will be considered as an alternate to the endsemester examination only. The internal assessment marks already secured by the students will be considered for finalizing the grade.
- 7. A minimum of 50 percent of marks prescribed for the end semester examination (40 percent in case of Arts and Science courses) should be scored in the supplementary examination(s) to declare the result as have passed the course and acquired the relevant number of credits.
